## **SECTION 4: First aid measures**

### 4.1. Description of first aid measures

First-aid measures after inhalation

Symptoms/effects after inhalation : This product has a low vapour pressure, and in normal conditions at ambient temperature the concentration in the air is negligible. A significant concentration may build up only if the

product is used at high temperature, or in case of sprays and mists. In these cases overexposure to vapours may cause irritation to airways, nausea and dizziness.

#### **Extinguishing media**

#### 6.1.2. For emergency responders

Protective equipment

: Small spillages: normal antistatic working clothes are usually adequate. Large spillages: full body suit of chemically resistant and antistatic material. if necessary heat resistant and insulated. Work gloves providing adequate chemical resistance, specifically to aromatic hydrocarbons. Gloves made of PVA are not water-resistant, and are not suitable for emergency use. If contact with hot product is possible or anticipated, gloves should be heat-resistant and thermally insulated. Antistatic non-skid safety shoes or boots, chemical resistant, if necessary heat resistant and insulated. Work helmet. Goggles and /or face shield, if splashes or contact with eyes is possible or anticipated. #### 6.2. Environmental precautions

Do not let the product accumulate in confined or underground spaces. Do not let the product flow into sewers or water courses, or in any way contaminate the environment. In case of contamination of environment compartments (soil, subsoil, surface or underground waters), remove contaminated soil when possible, and in any case treat all involved compartments in accordance with local regulations. The site should have a spill plan to ensure that adequate safeguards are in place to minimize the impact of episodic releases.

#### 6.3. Methods and material for containment and cleaning up

For containment

: Contain spilled liquid with sand, earth or other suitable absorbents (non-flammable). Recover free liquid and waste materials in suitable waterproof and oil-resistant containers. Clean contaminated area. Dispose of according to local regulations. If in water: Confine the spillage. Remove from surface by skimming or suitable floating absorbents. Collect recovered product and other waste materials in suitable waterproof, oil resistant containers. Recover or dispose of according to local regulations. Do not use solvents or dispersants, unless specifically advised by an expert, and, if required, approved by local authorities.

### SECTION 7: Handling and storage

#### 7.1. Precautions for safe handling

Precautions for safe handling

: This material is combustible, but will not ignite readily. Provide adequate ventilation. Use adequate personal protective equipment as needed. Due to the extremely slippery nature of this material, more care than usual must be exercised in material handling practices to keep off all walking surfaces. Floors, walls and other surfaces in the hazard area must be cleaned regularly. Avoid release to the environment. Emptied containers can contain combustible product residues. Do not cut, weld, drill, burn or incinerate empty containers or drums, unless they have been drained and cleaned. The product may release Hydrogen Sulphide: a specific assessment of inhalation risks from the presence of hydrogen sulphide in tank headspaces, confined spaces, product residue, tank waste and waste water, and unintentional releases should be made to help determine controls appropriate to local circumstances. #### 8.2. Exposure controls

#### Appropriate engineering controls:

Before entering storage tanks and commencing any operation in a confined area, carry out an adequate clean-up, and check the atmosphere for oxygen content, flammability, and the presence of sulphur compounds. See also Section 16, "Other information".

#### Personal protective equipment (for industrial or professional use):

Face shield. Gloves. Protective clothing. Safety glasses. Safety shoes or boots. Dust/aerosol mask.

#### Hand protection:

When there is a risk of contact with the skin, use hydrocarbon-resistant, felt-lined gloves. Adequate materials: nitrile (NBR) or PVC with a protection index > 5 (permeation time > 240 mins). Use gloves respecting all the conditions and within the limits set by the manufacturer. Replace gloves immediately in case of cuts, holes or other signs of damages or degradation. If necessary, refer to the EN 374 standard. Personal hygiene is a key element for an effective hand care. Gloves must be worn only with clean hands. After wearing gloves, hands must be carefully washed and dried.

#### Eye protection:
